



## Conditions of Sale

### 1. Bidding

All Bids must be made in New Zealand Dollars.

Bids can be made above or below our suggested estimate. Our estimate prices are a guide for your bidding and are conservative compared to retail prices.

Please tick the appropriate 'Percentage Increase' box on the bid form if you would like us to increase bids on your behalf in order for you to win the item.

Reserves are normally set at 80% to 90% of estimate.

We do not under any circumstances accept bids under 80% of the estimate.

In the case of a tie, the first bid received will win the lot.

Buy Bids are accepted but are subject to our discretion.

Successful bidders will pay the lowest possible price for any lot. Generally this will be either the reserve, the estimate or 10% above the second highest bidder.

By placing bids, the bidder is entering into a legal and binding contract to purchase all the lots won in the sale.

### 5. Catalogue Listings

### 6. Return Of Lots

If you believe that a lot has been incorrectly described you must return it within 48 hours of receipt and if we agree with you a replacement or credit will be arranged. In the event of a dispute the opinion of a mutually agreed authority will be sought and such opinion will be final.

The following lots are not returnable:

- Items illustrated in the catalogue are not returnable for visible faults.
- Items that have been immersed in water or subjected to a chemical process subsequent to sale.
- Collection, accumulation and kiloware lots.
- Lots that have been inspected by the purchaser prior to the sale.
